PEARSON, DAVID & FRANCIS DAMBACHER (hereinafter referred to as the “MORGAN AND SANGAMON COUNTY LANDOWNERS AND TENANT FARMERS”), by their attorneys, Gates, Wise & Schlosser, P.C., pursuant to the Case Management Plan entered December 14, 2012, and for their Identification of Alternate Route state as follows:

1. The MORGAN AND SANGAMON COUNTY LANDOWNERS AND TENANT FARMERS oppose that segment of AXTI’s proposed Primary Route which runs from Meredosia, Illinois to Pawnee, Illinois.

2. As an alternative to AXTI’s proposed Primary Route, the MORGAN AND SANGAMON COUNTY LANDOWNERS AND TENANT FARMERS prefer ATXI’s proposed Alternative Route as depicted in ATXI Petition Exhibit A (part 3 of 5) for that portion of the Project which runs from Meredosia, Illinois to Pawnee, Illinois.

3. A list of property owners who would be impacted by AXTI’s proposed Alternative Route for that portion of the project which runs from Meredosia, Illinois to Pawnee, Illinois is found at AXTI Petition Exhibit C on pages 41 through 46.

4. Alternatively, if AXTI’s proposed Alternative Route is rejected, the MORGAN AND SANGAMON COUNTY LANDOWNERS AND TENANT FARMERS prefer that the Project follow the route currently utilized by the existing 138 kV transmission line which runs from Meredosia, Illinois to Pawnee, Illinois as depicted in ATXI Petition Exhibit A (part 3 of 5) for that portion of the Project which runs from Meredosia, Illinois to Pawnee, Illinois.

5. A list of the names of the property owners on the existing 138 kV transmission line is attached hereto as Exhibit 1.




