SUBMISSION OF ALTERNATE ROUTE

2. We are suggesting the transmission line be moved to where there will be no homes or residents affected, which is roughly one half mile east of Ameren's suggested primary route of the segment that is originally along County Road 300E in Coles County, Illinois.
