**ADAMS COUNTY PROPERTY OWNERS AND TENANT FARMERS MOTION FOR
LEAVE TO SUPPLEMENT THE LIST OF LANDOWNERS AFFECTED BY ACPO
ALTERNATE ROUTE 1**

Adams County Property Owners and Tenant Farmers (hereinafter referred to as “ACPO”), by its attorneys, and moves to the ALJ for leave to supplement the list of landowners affected by ACPO Alternate Route 1:

1. On December 31, 2012, ACPO submitted its alternative routes along with a list of property owners affected by said routes.
2. ACPO identified an alternate route that it titled, “ACPO Alternate Route 1”, which tracks an existing Ameren 138,000 V transmission line in Adams County.
3. ACPO moves the ALJ for leave to supplement the list of affected landowners to include the property owners from bordering the Mississippi River to the SE Quincy Substation. These property owners would be affected if the Commission decides to adopt ACPO’s proposal, but were inadvertently omitted from ACPO’s December 31, 2012 filing.

4. Moreover, ACPO included a small number of Melrose Township property owners from the SE Quincy Substation to Burton Township who may be affected by ACPO Alternative Route 1.

5. The ALJ entered a ruling on January 2, 2013 granting certain Intervenors leave to supplement their December 31, 2012 filing to comply with the Case Management Plan. ACPO requests the ALJ grant ACPO leave to supplement its list of affected property owners consistent with the deadline set forth in the January 2, 2013 ruling.

6. A copy of the list of affected property owners is attached hereto as Exhibit A.

WHEREFORE, Adams County Property Owners and Tenant Farmers request the ALJ enter a ruling granting the Adams County Property Owners and Tenant Farmers leave to supplement the list of affected property owners, and grant them any additional relief the ALJ deems just and proper.




