WHEREAS, regardless of the number of years this bond shall remain in force and the premiums paid thereafter, the aggregate liability of the Surety hereunder is limited to the penal sum of the bond and any payment or payments made shall reduce the amount of the bond to the extent of such payment or payments.

NOW, Therefore, if the Principal fully and faithfully perform all duties and obligations of the Principal as an ABC, then this obligation to be void; otherwise to remain in full force and effect.


