MOTION TO WITHDRAW

I, Janet Roney, private citizen, whose residence is in close proximity to and whose land is crossed by the primary route of Ameren's Illinois Rivers Project in Moultrie County, Illinois, moves to withdraw from the above-entitled matter, and in support thereof, states the following reasons:

1. A Petition to Intervene was filed by me on December 31, 2012, which provided an alternate route for Ameren's proposed primary route across my farm. The Petition to Intervene was granted January 10th, 2013.


2. My petition proposed to move Ameren's line off the land of five farm owners and about 500 feet away from two residences.

3. I just now have been informed that not all of the land owners affected by my proposed alternate route approve of it.

4. Since no adjustments to my proposed alternate route can be made to satisfy their objections, and still maintain the original goal of my petition, and since I do not wish to proceed without the full approval of all my neighbors, I wish to withdraw my Petition to Intervene.

WHEREFORE, I, Janet Roney, respectfully pray that I be granted leave to withdraw as a party and for such other and further relief as is deemed just.




