VERIFIED PETITION OF COMCAST PHONE OF ILLINOIS, LLC d/b/a Comcast Digital Phone, d/b/a CIMCO, a Division of Comcast Business Services FOR PROPRIETARY TREATMENT OF ITS 2012 ANNUAL REPORT

Comcast Phone of Illinois, LLC d/b/a Comcast Digital Phone, d/b/a CIMCO, a Division of Comcast Business Services ("Comcast Phone ") hereby petitions the Illinois Commerce Commission ("ICC") for emergency relief to protect Petitioner's Annual Report from disclosure for not less than two years in order to protect the Company's highly proprietary information contained therein. In support of its Petition, Comcast Phone states as follows:

1. Comcast Phone has licenses from this Commission to provide facilities based and resold local exchange service and interexchange service in Illinois.
2. Comcast Phone is required to file its 2012 Annual Report with the ICC pursuant to 220 ILCS 5/5-109 of the Illinois Public Utilities Act.
3. Comcast Phone's Annual Report contains highly proprietary and confidential commercial and financial information. The disclosure of said information to competitors or potential competitors would be detrimental to Comcast Phone and provide an unfair advantage to Comcast Phone's competitors.

4. The telecommunications industry is highly competitive, and it is imperative that the proprietary information contained in Comcast Phone's 2012 Annual Report receive confidential treatment for at least two years following the issuance of an Order by this Commission.


5. Section 7 of the Illinois Freedom of Information Act (5 ILCS 140/7(g)) exempts from public disclosure "trade secrets and commercial or financial information . . . where the trade secrets or information are proprietary, privileged or confidential." Comcast Phone's 2012 Annual Report is protected by this exemption.

6. Comcast Phone seeks an Order from this Commission, without hearing, protecting the entirety of Comcast Phone's 2012 Annual Report from disclosure for a period not less than two years.

WHEREFORE, Comcast Phone respectfully requests that this Commission enter an Order, without hearing, protecting the entirety of Comcast Phone's 2012 Annual Report from disclosure for a period not less than two years.




