PETITION

NOW COMES T-NETIX Telecommunications Services, Inc. ("T-NETIX Telecom" or "Company") and petitions this Honorable Commission for withdrawal of its Certificate of Prepaid Calling Service Provider Authority to offer prepaid calling services to inmates in certain correctional facilities in the State of Illinois ("prepaid calling services"). In support of this Petition, T-NETIX Telecom states as follows:

1. T-NETIX Telecom holds a Certificate to operate as a provider of prepaid calling services pursuant to this Commission's Order in Docket No. 05-0438.
2. T-NETIX Telecom is not actively marketing prepaid calling services in the State of Illinois. Nor is it providing any such services.
3. As a result of the natural attrition of customers, T-NETIX Telecom currently has (and has had) no prepaid calling service customers in the State of Illinois. Accordingly, no customers exist to whom notice of discontinuance of services might be served. T-NETIX Telecom therefore respectfully requests that the Notice of Discontinuance required by Section 13-406 of the Public Utilities Act be waived.

4. T-NETIX Telecom further requests that since no parties will be prejudiced by the grant of this Petition the requirement for any hearing be waived or in the alternative any such hearing be held on a telephonic basis.

WHEREFORE, T-NETIX Telecommunications Services, Inc. respectfully requests that this Honorable Commission:

A. Grant its Petition for Withdrawal of Certificate of Prepaid Calling Service Provider Authority granted in Docket No. 05-0438;

B. Grant its request for waiver of the Notice of Discontinuance required by Section 13-406 of the Public Utilities Act;

D. Grant its request for waiver of a requirement for any hearing or in the alternative that any hearing be held telephonically; and

E. Grant any other appropriate relief consistent with the foregoing requests.




