IN HIS REVISED DIRECT TESTIMONY (ICC STAFF EXHIBIT 1.0R), STAFF WITNESS GREG ROCKROHR TESTIFIED THAT “ATXI’S PRIMARY ROUTE IS FAR SHORTER AND WOULD REQUIRE FEWER DEAD-END STRUCTURES, AND THUS IN MY OPINION IS THE BEST CHOICE” (LINES 1103-1104) WHEN ASKED WHICH OF THE ROUTE PROPOSALS FOR THE SEGMENT BETWEEN SIDNEY AND RISING REPRESENTS THE BEST CHOICE. HOW DO YOU RESPOND TO THIS?**

A. I have read the testimony of ICC Staff witness Greg Rockrohr and am in agreement with him that ATXI’s primary route is the best route proposed between Rising and Sidney.
