**MOTION FOR LEAVE *NUNC PRO TUNC* TO MARCH 28, 2013 THE  
DIRECT TESTIMONY OF Donna Allen**

Intervener, Donna Allen, respectfully requests that an order be issued granting her leave to submit nunc pro tunc to March 28, 2013, the Direct Testimony of Donna Allen. In support, Donna Allen states as follows:

1. On November 27, 2012, Donna Allen, submitted the petition to intervene, however she was unaware of the requirement of Proof of Service and Verification.
2. On December 20, 2012, Donna Allen, procured the required signatures and resubmitted her petition to intervene.
3. On December 31, 2012, Donna Allen, was granted leave to intervene in this cause.
4. On March 28, 2013, Donna Allen attempted to submit her direct testimony electronically.
5. On April 8, 2013, Donna Allen discovered that her attempt to submit Direct Testimony had not been received properly by the ICC Chief Clerks Office. Donna Allen accepts full

responsibility for this happenstance, but would urge that the same was not intentional or malicious.

6. On April 11, 2013, Donna Allen mailed a hard copy of the forms via overnight mail to the Chief Clerks Office for consideration.

7. On April 11, 2013, Ameren Transmission Company of Illinois ("ATXI") filed a motion to strike a portion of Donna Allen's testimony. In said motion, ATXI points out that the testimony has not been appropriately e-Docketed with the Commission.

8. As the direct testimony of Donna Allen was timely served on all of the parties to this proceeding, one day prior to the deadline for intervener direct testimony on Friday, March 29, 2013, no party should be surprised by the testimony of Donna Allen, or prejudiced by the submission of the same nunc pro tunc to March 28, 2013, when the original attempt to file the same was made.

9. The direct testimony of Donna Allen was received by the ICC Chief Clerks Office on April 12, 2013.

WHEREFORE, Intervener, Donna Allen, would request that an order be issued granting leave to submit nunc pro tunc to March 28, 2013, the Direct Testimony of Donna Allen and for any and all further relief which is just and equitable in this situation.
