**MOTION TO FILE SECOND AMENDED REQUEST FOR A WAIVER OF CERTAIN
CONTRACT PROVISIONS APPLICABLE TO THE INTERCONNECTION OF
DISTRIBUTED GENERATION FACILITIES**

COMES NOW Ameren Illinois Company d/b/a Ameren Illinois (“Ameren Illinois”, “AIC” or “the Company”) and moves for leave to file its Second Amended Request for a Waiver of Certain Contract Provisions Applicable to the Interconnection of Distributed Generation Facilities (“the Second Amended Request”). In support of its Motion, Ameren Illinois respectfully states as follows:

1. On April 9, 2013, Ameren Illinois filed a First Amended Request for a Waiver of Certain Contract Provisions Applicable to the Interconnection of Distributed Generation Facilities (“the First Amended Request”), requesting either a waiver of certain provisions of 83 Ill. Admin. Code Part 466 or a declaratory ruling finding that the contract described therein is exempted from compliance with certain provisions of Part 466.50 due to the preemptive effect of federal law.

2. Since the filing of the First Amended Request, Ameren Illinois has discovered an inadvertent error in a statement describing the electric generating capacity of the facilities at issue. In specific, the first sentence of Paragraph 3 of Ameren Illinois' First Amended Petition reads as follows: "The Army recently installed at a base located at 2611 Weiss Lane in Quincy, Illinois, several photovoltaic (“PV”) cells capable of generating 16.56 kilowatts of electricity

annually." This statement should read as follows: "The Army recently installed at a base located at 2611 Weiss Lane in Quincy, Illinois, several photovoltaic ("PV") cells with a generating capacity of 16.56 kilowatts."

3. For this reason, Ameren Illinois seeks leave to file a Second Amended Request, which is attached hereto as Exhibit A and incorporated by reference herein. Attached as Exhibit B is a letter issued on behalf of the Army, indicating that the Army has reviewed the Second Amended Request and consents both to the filing thereof and the relief requested therein. As indicated in the attached letter, the Army wishes to remain on the docket's service list via the following information:
