**NOTICE OF ADDITIONAL MEMBER OF RURAL CLARK AND

Intervenor, RURAL CLARK AND EDGAR COUNTY CONCERNED CITIZENS (“RCECCC”), by its attorney, William F. Moran, III, hereby notifies the Illinois Commerce Commission and the parties to this proceeding of the addition of a new member to its ranks, Mr. Gerald R. “Jerry” Forsythe of Marshall, Illinois. In support, RCECCC states as follows:

1. Mr. Gerald R. “Jerry” Forsythe is an interested landowner on the Kansas to Indiana State Line Alternative Route proposed by Petitioner, AMEREN TRANSMISSION COMPANY OF ILLINOIS (“AXTI”). Mr. Forsythe is listed on page 61 of AXTI’s Exhibit C attached to its original Petition for a Certificate of Public Convenience and Necessity filed in this cause on November 7, 2012. 5. Mr. Forsythe understands that under the present case management order in effect in this docket, his participation may be limited to an indication of support for the previous positions taken by the members of RCECCC.

6. In the event leave is required for the addition of Mr. Forsythe as a member of RCECCC on this docket, the members of RCECCC would so move for his addition and request that the Administrator Law Judges assigned to this matter enter an order memorializing this change to their membership.
