MOTION FOR LEAVE TO FILE
SECOND REVISED REBUTTAL EXHIBIT INSTANTER**

Ameren Transmission Company of Illinois (“ATXI”) pursuant to the Illinois Commerce Commission (“Commission” or “ICC”) Rules of Practice and Procedure, 83 Ill. Adm. Code § 200.190, hereby moves for an order granting leave to file a second revised ATXI Exhibit 10.2.

In support of this motion, ATXI states as follows:

1. On April 26, 2013, pursuant to the Case Management Plan adopted by the Administrative Law Judges, ATXI filed its Rebuttal Testimony in this proceeding.
2. The Rebuttal Testimony of ATXI witness Ms. Maureen A. Borkowski attached each of the stipulations entered between ATXI and intervening parties with respect to this proceeding as ATXI Exhibit 10.2. On May 6, 2013, ATXI filed a revised ATXI Exhibit 10.2 as an errata.
3. On May 10, 2013, ATXI entered a Stipulation with Moultrie County Property Owners (“MCPO”).

4. ATXI therefore seeks leave to file a revised version of ATXI Exhibit 10.2 (Rev.) that reflects this Stipulation. Filing of ATXI Exhibit 10.2 (2d Rev.) will allow the record in this proceeding to accurately reflect all stipulations entered between the parties.
