- 5) Munjed Al-Bakri (filed December 31, 2012).



NOTICE TO LANDOWNER

The enclosed notice of a status hearing is being mailed to you because you have been identified as an owner of property along one of the routes upon which Ameren Transmission Company of Illinois ("ATXI") proposes to construct facilities. ATXI filed its proposal with the Illinois Commerce Commission on November 7, 2012. The filing is identified as Docket No. 12-0598. The vast majority of potentially affected landowners have already received notice of this docket. You are receiving notice at this time because it was not until January 7, 2013 that ATXI realized that it had inadvertently not included you in the list of potentially affected landowners. Scheduling to address ATXI's proposed project will be discussed at the status hearing described in the attached notice. No witness testimony will be taken on that date.

You are advised that ATXI is seeking rulings that the proposed facilities are necessary and in the public interest and that ATXI be authorized or directed to construct the facilities. In addition, ATXI is seeking a ruling determining the proper location/routing of the proposed facilities. Whether ATXI's preferred route for the proposed facilities is the proper route will be determined in this proceeding. This docket is the only opportunity to contest the route of ATXI's proposed facilities. You are further advised that Illinois law allows the Commission only 225 days from the date of ATXI's filing to conclude this proceeding.

If the requested rulings are issued by the Commission and the proposed facilities are to be constructed on a route on your property, ATXI will attempt to negotiate acquisition of certain property rights from you. If after reasonable attempts to do so, no arrangement can be made between you and ATXI, ATXI may file a petition with the Commission seeking authority to obtain certain property rights from you through eminent domain so that it may construct the proposed facilities. You should understand that if your property lies in the path of the proposed facilities and ATXI at some later date files a petition with the Commission seeking eminent domain authority to obtain property rights from you, the propriety of the route for the facilities will no longer be a matter to be contested.

You are invited to attend the status hearing should you desire. Participation by telephone may be available. Any person who wishes to present evidence regarding the necessity for or the location of the proposed facilities must intervene, or be called as a witness by another party, and present that evidence in this proceeding. The date on which you may present such evidence will be determined at the status hearing described in the attached notice.
