VERIFIED PETITION TO INTERVENE
OF THE VILLAGE OF PEOTONE

The Village of Peotone, Will County, Illinois ("Village"), by its undersigned attorneys and pursuant to 83 Ill. Admin. Code §200.200, petitions the Illinois Commerce Commission for Leave to Intervene and participate as a party in the above-captioned proceeding. In support of its Petition, Village states as follows:

1. The Village of Peotone, Will County, Illinois, is a municipal corporation. Its address is: Village Hall, 208 E. Main St., P.O. Box 430, Peotone, IL 60468. 2. The Village of Peotone currently provides water and sewer services within its boundaries and intends to do so in the future within its planning area and within the area of its boundary agreements with all adjoining municipalities as the area develops. The Petition for a Certificate of Public Convenience and Necessity filed by Aqua Illinois, Inc. in this matter seeks a proposed certificated area for water that includes the Village of Peotone, its planning area and boundary agreement area. The Village has a direct interest in the provision of water and sewer to the requested area. Aqua's proposed certificated water area, among other things, conflicts with

the current and planned future operation of the Village water and sewer system, is believed to be excessive, does not promote the public convenience and is unnecessary.

3. The Village agrees to accept service by electronic means. Copies of all pleadings, notices, other documents and correspondence should be sent to the undersigned.

WHEREFORE, Village of Peotone prays that this Petition to Intervene be granted and that it hereinafter be treated as a party to this proceeding. Village further prays that Aqua's request for its proposed certificated area for water be denied or in the alternative be denied as to the territory within the boundaries of the Village, its planning area, and the territory covered by its boundary agreements with adjoining municipalities.




