STAFF'S ANSWER TO THE PETITION

Now comes the Staff of the Illinois Commerce Commission (Staff) and in support of its Answer to the City of Park Ridge's Petition for Approval of a 9-1-1 Emergency Telephone Number System, states the following:

1. The City of Park Ridge originally received an order to operate its Enhanced 9-1-1 System from the Commission on November 24, 1992, in Docket 92-0314. The Cities of Park Ridge and Des Plaines were granted authority to operate a 9-1-1 Emergency Telephone Number System as a joint emergency telephone system board (ETSB) in that docket.
2. On July 8, 2004, in Docket 04-0351, the joint ETSB of Des Plaines and Park Ridge requested and was granted a modification of the emergency telephone number system. In that order, the joint ETSB of Des Plaines and Park Ridge was combined with the 9-1-1 emergency telephone number systems of Morton Grove and Niles, Illinois, respectively. The four communities then began operations under a joint ETSB commonly referred to as the North Suburban Joint ETSB. The individual 9-1-1 systems in Morton Grove and Niles ceased operations.
3. On May 9, 2013, the North Suburban Joint ETSB filed a petition for modification of an existing 9-1-1 Emergency Telephone Number System in which it requested to dismiss the authority to operate an E9-1-1 system granted in Docket 04-0351. The Joint ETSB is dissolving pursuant to the terms of the intergovernmental agreement that originally established the Joint ETSB. The four member communities (Des Plaines, Park Ridge, Morton Grove and Niles) have chosen to re-establish their respective ETSBs and obtain 9-1-1 services elsewhere.
4. On May 9, 2013, in Docket 13-0355, the City of Park Ridge filed a Petition for Approval of a 9-1-1 Emergency Telephone Number System.
5. The Petition and application for the provision of 9-1-1 service meets the requirements as prescribed in Section 725.210 – Final Plans of 83 Illinois Administrative Code Part 725 - Standards of Service Applicable to 9-1-1 Emergency Systems.

6. Staff has thoroughly reviewed City of Park Ridge's Petition for Approval of a 9-1-1 Emergency Telephone Number System and supports the petitioners' request for approval. In addition, Staff supports waiving a hearing in this docket as requested by petitioner as there are no objections from Commission Staff or any other party.






