



Code § 200.890, Ill. S. Ct. R. 303 and 335, and other applicable law, hereby appeals to the Appellate Court of Illinois, Second Judicial District, from the following orders of the Illinois Commerce Commission (the “Commission” or “ICC”) in *Northern Illinois Gas Company d/b/a Nicor Gas Company: Reconciliation of Revenues collected under Gas Adjustment Charges with Actual Costs prudently incurred; Proceeding to review Rider 4, Gas Cost, pursuant to Section 9-244(c) of the Public Utilities Act*, ICC Docket Nos. 01-0705, 02-0067, and 02-0725: the Order dated June 5, 2013, and the Commission’s decision on June 27, 2013 denying Nicor Gas’ application for rehearing. Nicor Gas seeks relief reversing in part the

above orders of the Commission and remanding this matter to the Commission for appropriate further proceedings and the entry of an appropriate order on remand.
