**SECOND SUPPLEMENTAL JOINT PETITION**

JO-CARROLL ELECTRIC COOPERATIVE, INC. "JO-CARROLL" by its attorneys, John Cox and Grosboll, Becker, Tice & Reif, Jerry Tice of Counsel, and INTERSTATE POWER COMPANY (a wholly owned subsidiary of Alliant Energy Corporation) "INTERSTATE" by its attorney Kent Ragsdale, as Joint Petitioners, respectfully represent to the Illinois Commerce Commission, "COMMISSION" as follows:

1. Upon request from the COMMISSION, INTERSTATE and JO-CARROLL provide the following information:
  - A. The US Army was the only the only customer that was served by INTERSTATE. Any other individuals and/or entities were served by distributions from the Savanna Army Depot and were not INTERSTATE customers.
  - B. The individuals and/or entitles served by the Army Depot were aware of the sale of the property from INTERSTATE to JO-CARROLL. They were not given written notice of the

sale, however, it was public knowledge that the system would be sold since bids were taken once the US Army determined it would liquidate all of its infrastructure ownership in the Depot.

B. The US Army continues to be served as it concludes its decommissioning of the Depot, and the nature of the service to the individuals and/or entities that take service from the Depot will not change as a result of the sale.

**WHEREFORE**, the Joint Petitioners request the COMMISSION approve the Partial Service Area Agreement marked Exhibit A which is attached hereto and which defines the territory which JO-CARROLL will provide exclusive electric service to all pursuant to Section 6 of the E.S.A.
