On 07-26-11 at approximately 1510 hrs I was dispatched to 5 Starwood Ct in reference to a residential burglary. Upon arrival I met with Jordan, Cheryl who related the following in summary: The residence located at the above location has been vacant for approximately one year and is in a short sale through Chase Bank. She was contacted by the water company advising her there was an unusually high usage of water from May 2011 to June 2011.


On today's date she met with an employee from the water company at the residence to determine the location of the running water.

When she entered the basement she observed a high amount of mold on the walls and copper pipes missing from the water softener however no running water at the time. She then called the Bolingbrook Police Department for further assistance.

While on scene I observed a water softener with copper pipes missing located in the southeast corner of the basement. There also appeared to be approximately five feet of copper pipe missing from the ceiling above the water softener.

Cheryl related all doors were secure and she does not know who took the copper or when it was taken.
