

Nicas Talk w/ Both Sides of Mouth

- 1) On May 3rd, day after I was disconnected on May 2nd 2013, I was qualified by CEDA for assistance. Per their instruction I paid \$75 (good faith pay) to currency exchange, took receipt back to CEDA, they fax everything to Nicas & asked me to call Nicas for appointment. Nicas told me they came in couple of days (there is witness to this call. CEDA people asked me to go to auto lobby since I was loud). Everything was done same day. As Nicas said couple of days later 5/16 I was connected. Nicas received \$598 from CEDA on 5/20, balance of 240.18 from me few days later. On June 26th, 13 they disconnected me again without any notice.
- 2) There is only 3 scenarios. If they didn't know I had gas; why they left me without so long & until second coming on June 26th when they disconnected me again, they had good faith pay, promise fax from CEDA, appointment call from me or at least from 5/20 when they physically had money from CEDA & me for entire bill. Next is if they knew I had gas but they didn't connect, why they weren't concern w/ safety & chastise for it so late on June 26th. Next if they connected me as happened & on May 6th, why they disconnected me again on June 26th when every thing was paid & next bill was issued June 28th which is after.
- 3) The whole thing is retaliation for my response to supervisor when he talked me down & I said oil & gas company pay less than bottled water, sell it 50 times more fattening their bellies... They have send me another harrasing letter July 23rd, exact same day of eviction filing which show on clerk of Cook County web site making them ascertain of magnitude of harm, knowing I haven't complain yet, hoping to stop me w/ fear of another disconnection, partial rent pay & eviction which can lead to loosing my building.


