Please accept this letter as Locus Telecommunications, Inc.'s ("Locus") request to voluntarily cancel its Certificate of Prepaid Calling Service Provider Authority in the State of Illinois granted in Docket No. 05-0400 on August 3, 2005.

On August 31, 2013, Locus intends to complete the merger transaction to merge with and into Total Call International, Inc. ("TCI"). Locus will be the Merging Corporation and TCI will be the Surviving Corporation; the separate existence of Locus will cease. 


