FIFTH REPORT

The Peoples Gas Light and Coke Company ("Company") respectfully submits this fifth report, for the period ended June 30, 2013, with respect to the bonds authorized by the order of the Commission entered on June 27, 2012, in the above-entitled Docket No. 12-0339. (Reference is made to the initial report to the Commission in this Docket for the period ended June 30, 2012, dated August 22, 2012.)

On December 4, 2012, the Company issued \$100,000,000 in principal amount of its First and Refunding Mortgage Bonds, Series YY, to the initial purchasers, Teachers Insurance and Annuity Association of America, New York Life Insurance Company, New York Life Insurance and Annuity Corporation, United of Omaha Life Insurance Company, and CMFG Life Insurance Company, at 100% of the principal amount (i.e., \$100.00 per one hundred dollars face amount) for an aggregate consideration of \$100,000,000. The Series YY Bonds, which will mature on December 1, 2042, bear an interest rate of 3.98% per annum.

The proceeds realized from the sale of the Series YY Bonds have been used for the purpose of refunding short-term indebtedness.

No entity is or became an "affiliated interest" of the Company within the meaning of section 7-101 of the Illinois Public Utilities Act as a result of the sale

of the Series YY Bonds.


