3. Petitioners will be substantially affected by any decision of the Illinois Commerce Commission in the above-captioned docket.

4. Petitioners are prepared to and do accept the record and procedural schedule established to date in this docket.

5. Petitioners seek to be treated as active parties in this proceeding to protect their interests.


6. Petitioners will accept electronic service in this proceeding, and would request that their below-identified attorney be added to the service list in this cause.






