ARTICLES OF INCORPORATION
OF
READY WIRELESS, INC.

The undersigned individual, acting as the incorporator of a corporation organized under the Iowa Business Corporation Act, Chapter 490 of the Iowa Code, as amended (the "Act"), does hereby adopt the following Articles of Incorporation:

ARTICLE I

CORPORATE NAME AND DURATION

The name of the Corporation is "READY WIRELESS, INC." The existence of the Corporation will become effective upon filing of these Articles with the Secretary of State, and continue perpetually thereafter unless dissolved as provided by law.

ARTICLE II

POWERS

The Corporation will have unlimited powers to engage in and do any lawful act concerning any and all lawful business for which corporations may be organized under the Act.

ARTICLE III

CAPITAL STOCK

A. The maximum number of shares of stock that the Corporation will have authority to issue is 1,000,000, all of which will be voting Common Stock without par value.

B. At all times, each holder of Common Stock of the Corporation will be entitled to one vote for each share of Common Stock standing in the name of the holder on the books of the Corporation.

C. Restrictions on the transfer of any shares issued by the Corporation may be imposed either by agreement or in the By-Laws.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial Registered Office of the Corporation is 115 THIRD STREET SE, SUITE 1200, CEDAR RAPIDS, IOWA 52401-1266, and the initial Registered Agent at such address is DAVID J. ZYLSTRA.

ARTICLE V

DIRECTORS

A. The business affairs of the Corporation will be managed and controlled by the Board of Directors.

B. The Corporation will have at least one Director but not more than seven Directors. The Directors may, by resolution, fix and determine from time to time the number of Directors within the authorized range.

C. The terms of Directors may be staggered on a basis set forth in the By-Laws and in accordance with law.

D. Two Directors will constitute the initial Board of Directors and the names and addresses of the persons who are to serve as Directors for the first fiscal year and until their successor(s) are elected and qualified are:

ARTICLE VIII

PERSONAL LIABILITY

A. A Director of this Corporation will not be personally liable to the Corporation or its Shareholders for monetary damages for any action taken, or any failure to take any action, as a director, except for liability for any actions for which the Act does not permit the Corporation to limit or eliminate the liability of a Director.

B. If the Act is amended after the effective date of these Articles to authorize the further elimination or limitation of the liability of Directors, then the liability of Directors will be eliminated to the fullest extent authorized by the Act, as so amended.

C. No amendment to or repeal of this Article will apply to or have any effect on the liability or alleged liability of any Director of the Corporation for or with respect to any acts or omissions of such Director occurring before such amendment or repeal.

ARTICLE IX

INDEMNIFICATION

This Corporation may indemnify a Director or Officer of this Corporation, and each Director or Officer of this Corporation who is serving or who has served, at the request of this Corporation, as a director, officer, partner, member, manager, trustee, employee or agent of another corporation, partnership, joint venture, limited liability company, trust, other enterprise or employee benefit plan to the fullest extent possible under the Act or other applicable law against expenses, including attorney fees, judgments, fines, settlements and reasonable expenses, actually incurred by such Director or such Officer relating to his or her conduct as a Director or Officer of this Corporation or to his or her conduct as a director, officer, partner, member, manager, trustee, employee or agent of another corporation, partnership, joint venture, limited liability company, trust, other enterprise or employee benefit plan, except to the extent any provision of the Act would prohibit the Corporation from indemnifying such Director or such Officer.

ARTICLE X

AMENDMENT

No amendment of these articles shall be permitted without approval by a majority vote of the outstanding voting shares of the Corporation.
