REQUEST NO. AG 4.01:

Re: ComEd Ex. 13.0 (Tenorio), page 26. Concerning the table on this page:

- (a) Does the table on this page show percentage changes in the total electric bill, or percentage changes in the portion of the bill for distribution service (that is, excluding supply charges)?
- (b) If the table shows percentage changes in the total bill for electric service, please provide a similar table showing percentage changes in the portion of the bill for distribution service (that is, excluding supply charges).

RESPONSE:

- (a) Table CST S-3 on page 26 of ComEd Ex. 13.0 shows percentage changes in the total electricity bill including purchased electricity (supply) charges, PJM services (transmission) charges, as well as other miscellaneous charges/credits on a customer bill such as Retail Customer Assessments (Rider RCA), Environmental Cost Recovery Adjustment (Rider ECR), Energy Efficiency and Demand Response Adjustment (Rider EDA), Franchise Cost Addition (Rider RCA) and Incremental Uncollectibles (Rider UF) for supply and delivery.
- (b) Please see Table DR AG 4.01 which shows percentage changes in the delivery service only portion of a bill. The only charges included are the Customer Charge, Standard Metering Service Charge, Distribution Facilities Charge (DFC) and Illinois Electricity Distribution Tax Charge (IEDT).
