1 THE COURT: Pursuant to the authority of the  
2 Illinois Commerce Commission, I now call Docket 13-0642,  
3 Solar Service, Inc.

4 This is an application for certifications as  
5 an installer of distributed generation facilities.

6 Counsel, could you please state your name for  
7 the record.

8 MR. OMONIYI: A. Olusanjo Omoniyi, staff of  
9 Illinois Commerce Commission.

10 THE COURT: Okay. It's my understanding that  
11 somebody from Solar Services contacted me, as well as  
12 you, Counsel, that they are waiving their right to  
13 appear today. Is that correct?

14 MR. OMONIYI: That's correct.

15 THE COURT: Okay. And at this time, a verified  
16 statement has been filed.

17 Would you like to enter that into the record,  
18 and is there anything to explain with the verified  
19 statement?

20 MR. OMONIYI: Yes, I can. I filed a verified  
21 statement. Upon review, the application of Solar  
22 Service, Inc., and I went through all the documents that  
23 were submitted.

24 When we felt that we needed more additional  
25 information, I called the company and the company

1 responded immediately. They provided me with affidavits  
2 showing that five of their employees had installed solar  
3 installations of more than five indicating that they're  
4 qualified as installers of solar panels.

5           Also, one of the staff also presented a  
6 certificate from the North American Board of Certified  
7 Energy Practitioners, NABCEP, showing that he had  
8 undergone the required training as a DG installer of  
9 solar panels. And this shows that all their six  
10 employees have individually met the requirement to be  
11 qualified DG installer.

12           I attached just about all the information I  
13 got from the company, and I recommend that Solar  
14 Service, Inc., of Niles, Illinois be certified as DG  
15 installer.

16           THE COURT: And is this the same as the previous  
17 where it's for wind turbine and solar installations?

18           MR. OMONIYI: Solar Service, Inc., is only for  
19 solar panel installations.

20           THE COURT: Okay.

21           MR. OMONIYI: So they didn't do any other DG  
22 installation other than solar.

23           THE COURT: Okay. So going forward, these  
24 applications, they'll enumerate -- there is no  
25 presumption there. They'll enumerate exactly what

1 they're requesting.

2 MR. OMONIYI: Yes.

3 THE COURT: Okay. Let the record reflect, then,  
4 that Staff Exhibit 1, which is the verified statement,  
5 is entered into the record.

6 Is there anything further?

7 MR. OMONIYI: No.

8 THE COURT: Okay. I'll mark the record heard and  
9 taken.
