**PETITION FOR LEAVE TO INTERVENE**

Pursuant to §200.200 of the Rules of Practice of the Illinois Commerce Commission ("Commission"), 83 Ill. Adm. Code 200.200, THE FOREST PRESERVE DISTRICT OF KANE COUNTY ("District") by and through its attorneys, Kinnally, Flaherty, Krentz, Loran, Hodge & Masur, P.C., file this Petition for Leave to Intervene (its "Intervention"), seeking authority thereby to intervene and participate fully as a party in the above-captioned proceeding. In support of his Intervention, Tomaszewicz states as follows:

1. On December 2, 2013, Commonwealth Edison Company ("Com Ed") filed its Petition seeking both a Certificate of Public Convenience and Necessity to construct, operate, and maintain an electric transmission line ("Transmission Line"), and an Order from the Commission authorizing and directing ComEd to construct the Transmission Line.

2. In the ComEd Petition, and its accompanying prepared written testimony and exhibits, ComEd proposes certain "Primary" and "Alternate" routes.

3. The District holds title to certain property in Kane County over which one proposed route of the Transmission Line runs (the "District Property"). Transmission Line will be located within the District Property.

4. The parcels constiuting the District Property are listed in Exhibit D to ComEd's Peition.

5. Accordingly, the District is interested in the subject matter of this proceeding and may be affected by any order entered or other relief granted by the Commission.

6. No other party is able adequately to represent or protect the District's interests.

7. The District agrees to accept service by electronic means as provided for in §200.1050 of the Commission's Rules of Practice. 83 Ill.Adm. Code §200.1050.


9. Pending a ruling on this Petition for Leave to Intervene, the District respectfully requests that the Administrative Law Judge permit him to participate in this proceeding.




