PETITION FOR LEAVE TO INTERVENE

Pursuant to §200.20 of the Rules of Practice of the Illinois Commerce Commission (Commission”), 83 Ill. Adm Code 200.200, RONALD E. AND CAROL J. NIGHTINGALE (“Nightingales”), file this Petition for Leave to Intervene (their “Intervention”), seeking authority thereby to intervene and participate fully as parties in the above-captioned proceeding. In support of their Intervention, Nightingales state as follows:

1. On December 2, 2013 Commonwealth Edison Company (ComEd”) filed its Petition seeking both a Certificate of Public Convenience and Necessity to construct, operate, and maintain an electric transmission line (“Transmission Line”), and an Order from the Commission authorizing and directing ComEd to construct the Transmission Line.
2. In ComEd’s Petition and its accompanying prepared written testimony and exhibits, ComEd proposes certain “primary” and “alternate” routes.
3. Nightingales hold title to property, which includes a residence and 36 acres of land, some of which is used for agriculture and some that is heavily wooded. As proposed, the alternate route of the Transmission Line will be located within a few hundred feet of the home site and will otherwise interfere with and impair the operation, use, and enjoyment of the Nightingales’ property.
4. The parcels constituting the Nightingales’ property are listed in Exhibit D to ComEd’s Petition.

5. Accordingly, the Nightingales are interested in the subject matter of this proceeding and may be affected by any order entered or other relief granted by the Commission.

6. No other party is able to adequately represent or protect the Nightingales' interests.

7. Nightingales agree to accept service by electronic means as provided for in §200.1050 of the Commission's Rules of Practice. 83 Ill. Adm. Code §200.1050.






