**PETITION TO INTERVENE OF THE
CITY OF SYCAMORE**

Pursuant to Section 220.200 of the Rules of Practice of the Illinois Commerce Commission, 83 Ill. Adm. Code § 200.200, and Section 10-108 of the Public Utilities Act, 220 ILCS 5/10-108, the City of Sycamore ("Sycamore") hereby files its Petition to Intervene, seeking authority to intervene and participate fully as a party in the above-captioned proceeding. In support of its Petition, Sycamore states as follows:

1. On December 2, 2013, Commonwealth Edison Company ("ComEd") filed its Petition seeking a Certificate of Public Convenience and Necessity to construct, operate and maintain an electric transmission line (the "Grand Prairie Gateway Line"), and an Order from the Commission authorizing ComEd to construct the Grand Prairie Gateway Line.

3. The proposed route of the Grand Prairie Gateway Line runs through the corporate limits of Sycamore.

5. Based upon the foregoing, Sycamore is interested in the subject matter of this proceeding and will be affected by an order entered or other relief granted by the Commission.

6 Sycamore is authorized to appear and present evidence in this matter pursuant to Section 10-108 of the Public Utilities Act, which provides that “in any case of any inquiry, investigation or hearing by or before the Illinois Commerce Commission on any matter relating to the rates or other charges or services within any city, the city...shall be entitled to appear and present evidence relating to the subject of such inquiry investigation or hearing.” 220 ILCS 5/10-108.

7. No other party is able to adequately represent or protect Sycamore’s interest in this proceeding.

8. Sycamore agrees to accept service by electronic means as provided for in Section 200.1050 of the Commission’s Rules of Practice 83 Ill. Admin Code § 200.1050.


