PETITION FOR LEAVE TO INTERVENE OF
OGLE COUNTY

Pursuant to Section 200.200 of the Rules of Practice of the Illinois Commerce Commission, 83 Ill. Adm. Code § 200.200, the County of Ogle ("Ogle County"), files this Petition for Leave to Intervene (its "Intervention"), seeking authority thereby to intervene and participate fully as a party in the above-captioned proceeding. In support of its Intervention, Ogle County states as follows:

1. On December 2, 2013, Commonwealth Edison Company ("ComEd") filed its Petition seeking a Certificate of Public Convenience and Necessity to construct, operate, and maintain an electric transmission line ("Transmission Line"), and an Order from the Commission authorizing and directing ComEd to construct said Transmission Line.

2. In ComEd's Petition, and its accompanying prepared written testimony and exhibits, ComEd proposed certain "Primary" and "Alternate" routes.

3. The proposed route of the Transmission Line runs through the limits of Ogle County.

4. Accordingly, Ogle County is interested in the subject matter of this proceeding and may be affected by any order entered or any relief granted by the Commission.

7. No other party is able to adequately represent or protect Ogle County's interests in this proceeding.

8. Ogle County agrees to accept service by electronic means as provided for in Section 200.1050 of the Commission's Rules of Practice, 83 Ill. Admin Code § 200.1050.




