SUPPLEMENT TO APPLICATION

MP2 Energy NE LLC ("Applicant") wishes to supplement its Application for Certificate of Service Authority to provide additional information as follows:

1. With respect to paragraph 25 of the Application regarding agents and contractors it should be amended to read Applicant is relying on one or more agents or contractors to meet the technical and managerial requirements of Part 451.330 and 451.340 of the Illinois Public Utilities Act (the "Act"). Applicant certifies that all of its agents or contractors will comply with all Sections of Part 451 applicable to the function or functions to be performed by the respective agent or contractor.
2. Applicant and its parent, MP2 Energy LLC ("MP2 Energy"), have entered into an agreement (the "Agreement") for the provision of MP2 Energy personnel to satisfy the managerial and technical requirements imposed upon Applicant pursuant to Part 451.330 and 451.340 of the Act.
3. Applicant certifies that it will provide notice to the Commission in the event the Agreement is terminated or there are changes in the persons upon whom it relies to meet the managerial and technical requirements.
4. The persons identified in the Application and whose qualifications are set forth in Exhibit E of the Application meet the managerial and technical requirements and will provide the services pursuant to the Agreement. Applicant is therefore relying on one or more agents or contractors to meet the requirements. The Agreement between Applicant and MP2 Energy is attached hereto as Attachment 1.

5. Applicant has attached a corporate organizational chart for it and its affiliates as Attachment 2. The corporate chart in Attachment 2 supplements the chart attached to the Application as Attachment F.






