NOW COMES the Union Pacific Railroad Company (“the Railroad”), through its
respective attorney, Mack H. Shumate, Jr., with its Motion to Continue the hearing scheduled for
March 12, 2014 at 2:00 p.m., and in support thereof, states as follows:

1. The City is seeking an order from the Commission authorizing the installation and
maintenance of the at-grade pedestrian crosswalk referenced above to promote public safety and
convenience in conjunction with the Illinois Department of Transportation’s (“IDOT”) Bureau of
High Speed and Passenger Rail program.

2. This matter is now set for hearing on March 12, 2014 at 2:00 p.m. before the
Honorable Timothy Duggan, Administrative Law Judge.

3. I, Mack H. Shumate, Jr. have a scheduling conflict and will be out of the State of
Illinois on another matter for the Railroad on March 12, 2014.

4. The attorneys for both the City of Lincoln and IDOT and the representative of the staff of the Illinois Commerce Commission (“ICC”) have been consulted with concerning the scheduling conflict and agree that an alternative date of April 2 is mutually acceptable.

WHEREFORE, the Railroad respectfully requests that the Commission enter an order continuing this matter from March 12, 2014 to April 2, 2014.
