ANPI, LLC ("ANPI" or "Petitioner"), hereby respectfully requests that the Commission issue an order permitting the Petitioner's 2013 Illinois Annual Report to be filed under seal of confidentiality and withheld from public inspection.

Petitioner is certificated by the Commission to provide competitive telecommunications services in the State of Illinois, and as such is required to file an Annual Report pursuant to Section 5-109 of the Public Utilities Act ("Act") 220 ILCS 5/1-101 *et seq.*

The Petitioner is a privately-held Company and, as such, is not required to disclose its financial information to the public in the ordinary course of business. Release of the Confidential Information to the public is not essential to the Commission's review of the Petitioner's Annual Report and is of no benefit to the general public.

The Confidential Information, which is comprised of sensitive financial information that the Petitioner considers highly confidential and proprietary, would be of significant benefit to the Petitioner's competitors. By reviewing the Confidential Information, competitors could determine the extent of the Petitioner's operations, including its cash position, liabilities, revenues, expenses, and other data that the Petitioner considers highly proprietary and confidential. Disclosure of such information to the Petitioner's competitors could cause significant and possibly irreparable financial and operational harm to Petitioner and would

place the Petitioner at an unfair business disadvantage in a competitive telecommunications market.

Section 7(g) of the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq., exempts from disclosure: Trade secrets and commercial or financial information obtained from a person or business where such trade secrets or information are proprietary, privileged or confidential, or where disclosure of such trade secrets or information may cause competitive harm;

For the reasons stated herein, Petitioner submits that good cause exists for the Commission to permit the Confidential Information to be filed under seal of confidentiality and withheld from public inspection.

WHEREFORE, ANPI, LLC respectfully requests that its Petition to file its 2013 Illinois Annual Report under seal of confidentiality for not less than two years be granted.


