3. January 2011-December 2011 "All distance" package billed at \$40.00 without rate increase.
4. January 2013 added \$2.00 rate increase stated "All distance " package will rise from \$35.00 to \$37.00 but i was billed between \$40.00-\$47.00 through december 2012
5. January 2013 added a \$2.00 rate increase which should have resulted in \$37.00 \$39.00 a month but instead i was billed \$49.00 a month for the entire year of 2013
6. All in all I accumulated more than \$300.00 for four years i Over charges before taxes.


