**SECOND AFFIDAVIT OF ROBERT B. LOCKHART, TRUSTEE OF
THE LOCKHART LIVING TRUST DATED AUGUST 26, 1996**

Robert Bruce Lockhart, being first duly sworn on oath, deposes and states that he has personal knowledge of the facts contained herein and if called as a witness in this cause, he would testify as follows:

INTRODUCTION

1. I am over the age of 18 and I am competent to testify herein.
2. I am the Trustee for the Lockhart Living Trust Dated August 26, 1996 (hereinafter "Lockhart") which owns property in Christian County, Illinois, which is significantly adversely impacted by the Ameren Transmission Company of Illinois (hereinafter "ATXI") Alternate Route 2 of the Pawnee-Pana Segment described in Section VIII of the Second Order on Rehearing in this docket dated February 20, 2014.

3. I have read the Response of ATXI to the Petition for Rehearing. I am reaffirming that, as stated in my Affidavit and those of co-property owners Rhonda Brockett and Cheryl Given, we received no notice of ICC Docket 12-0598, no notice of the proposed ATXI routes through the Pawnee-Pana Segment, and no notice of ATXI's Alternate Route 2 or any modifications to ATXI's Alternate 2 Route.

4. As attached to my original affidavit, Lockhart Aff. Exhibit 1, a Plat of Survey, shows that there are **two** tax identification numbers for the parcels identified on the Exhibit 1 as Parcels A and B. Parcel A, Tax I.D. Number 11-25-06-300-006-00 is owned by my aunt and uncle, Juanita and Dean Brownback. (See <http://christian.il.bhamaps.com> search for Tax I.D. Number 11-25-06-300-006-00). Mrs. and Mrs. Brownback are in their 90's and reside in the family farm house on their property.

5. Parcel B depicted on Exhibit 1 has a different Tax I.D. Number 11-25-06-400-001-00. Parcel B is the Property owned by the Lockhart Family Trust, Cheryl Given and Rhonda Brockett. Juanita Brownback is not the owner of Parcel B, nor was she ever authorized by the Lockhart Family Trust, or co-owners of Parcel B to be listed as the owner of the property.

6. At no time did Juanita Brownback send to me, Cheryl (Gresham) Given or Rhonda (Gresham) Brockett of any notice she received in error for the Lockhart/Given/Brockett Parcel B.

7. The notice sent by ATXI after the entry of the Second Order on Rehearing was mailed to Mr. Mike Schafer lives at 2233 E 400 North Road, Pana, Illinois 62557, which is a location almost 2 miles away from the Lockhart/Given/Brockett Property and

is unrelated to our Property or the Brownback Property. It was not mailed to the address for Juanita Brownback.
