2. DoD/FEA operates the Rock Island Armory ("RIA"), an Army installation located in Rock Island County, Illinois. RIA is in MidAmerican Energy Company's ("MidAmerican") service territory and will be affected by the instant matter wherein

MidAmerican is seeking a rate increase. Energy expenses come out of operations and maintenance budgets, and any increase allowed will affect DoD/FEA and its operations at RIA.

3. DoD/FEA has no means to adequately protect its consumer interests other than by intervention in this proceeding.

4. DoD/FEA may submit testimony and exhibits, file briefs, and may choose to participate at hearings, including cross-examining witnesses of parties and other interveners and redirect of any DoD/FEA witness, after making any such witness available for cross-examination.


5. For the reasons discussed herein, DoD/FEA respectfully requests leave to intervene as an active party to this proceeding.




