**VERIFIED PETITION OF CHARTER FIBERLINK - ILLINOIS, LLC FOR
CONFIDENTIAL TREATMENT OF 2013 ANNUAL REPORT**

Charter Fiberlink - Illinois, LLC ("Charter Fiberlink") hereby petitions the Illinois Commerce Commission (the "Commission") to grant proprietary and confidential treatment of Charter Fiberlink's 2013 Annual Report. In support of this petition, Charter Fiberlink states as follows:

1. Charter Fiberlink is certified to provide local exchange and interexchange telecommunications services within the State of Illinois and competes with local exchange and interexchange carriers, as well as with others providing communications services.

2. Charter Fiberlink is required to file annual reports with the Commission until such time as the Commission determines that such reports are not required. See 220 ILCS 5/13-101, Sec. 13-401 of the Public Utilities Act. 220 ILCS 5/5-109, Sec. 5-109 of the Public Utilities Act provides that the Commission may direct that annual reports be maintained as confidential and proprietary information of the filing entity.

3. Charter Fiberlink's 2013 Annual Report contains specific commercial and financial information concerning its operating revenues and expenses in Illinois. Such information is highly competitive, sensitive, proprietary, confidential and of the type that would be of particular interest to Charter Fiberlink's competitors or potential competitors.

4. 220 ILCS 5/4-404, Sec. 4-404 of the Public Utilities Act states that the Commission must provide adequate protection for confidential and proprietary information furnished, delivered or filed by any person, corporation or other entity. 5 ILCS 140/7, Sec. 7(2)(g) provides for protection of trade secrets and commercial or financial information furnished under a claim that they are proprietary, privileged or confidential, and that disclosure of such information would cause competitive harm to the person or business. Charter Fiberlink's 2013 Annual Report contains such confidential and proprietary information, trade secrets, and commercial and financial information, including the specific information in the 2013 Annual Report regarding Charter Fiberlink's operating revenues and expenses in Illinois. Charter Fiberlink as a matter of internal company policy and practice keeps such information confidential in perpetuity.

5. The Commission previously has afforded proprietary and confidential treatment to the same type of information for a period of not less five (5) years. *See, e.g.*, Final Orders issued July 7, 2011 in Commission Dockets No. 08-0225 and 08-0226. *See also* Commission Rule 200.430(b) (five (5) year period applicable to proposed expiration dates of protective orders).

6. Accordingly, it is imperative that the Commission maintain Charter Fiberlink's 2013 Annual Report under seal for as long as permitted under law and, in any event, not less than five (5) years following the issuance of an order in this proceeding. Disclosure of the 2013 Annual Report at an earlier date would cause Charter Fiberlink serious competitive harm because it would give competitors information and data regarding Charter Fiberlink's finances, relative position and scope of entry in the marketplace for communications services in Illinois.

7. Copies of all pleadings, notices and correspondence in this docket should be sent to the undersigned.

8. Charter Fiberlink agrees to accept service by electronic means as provided for in the Illinois Administrative Rules.

WHEREFORE, for the above-stated reasons, Charter Fiberlink requests that the Commission issue an order, without hearing, granting proprietary and confidential treatment and protection from disclosure of Charter Fiberlink's 2013 Annual Report for as long as permitted under law and, in any event, not less than five (5) years following the issuance of an order in this proceeding.
