Interstate Gas Supply of Illinois, Inc., a wholly owned subsidiary of Interstate Gas Supply, Inc. dba IGS Energy ("IGS Energy"), respectfully submits this Supplemental Verified Response to the Administrative Law Judge's ("ALJ") April 15, 2014 Ruling in supplement to IGS's April 8, 2014 Petition to cancel service authority to operate as an Alternative Gas Supplier and states as follows:

Pursuant the ALJ Ruling, IGS Energy will provide direct notice to its customers that gas service is being transitioned from Interstate Gas Supply of Illinois, Inc. to Interstate Gas Supply, Inc. though a postcard mailed to each customer. The language of the message is as follows:


"Your service by Interstate Gas Supply of Illinois, Inc. is now provided by Interstate Gas Supply, Inc."

Per the ALJ ruling, a copy of the customer communication is attached to this filing. IGS will have completed noticing customers no later than two months of this filing. All other terms and conditions for customers being served by Interstate Gas Supply of Illinois, Inc.

will remain the same, and customers will receive no material change in their natural gas service from IGS Energy.




