**VERIFIED AMENDMENT TO THE VERIFIED PETITION
OF COMMONWEALTH EDISON COMPANY**

Commonwealth Edison Company (“ComEd”), pursuant to Section 200.140 of the Rules of Practice of the Illinois Commerce Commission’s (“ICC” or “Commission”), 83 Ill. Admin. Code § 200.140, submits this Amendment (“Amendment”) to its Verified Petition (“Petition”) seeking issuance, under Section 8-406.1 of the Public Utilities Act (“PUA”), 220 ILCS 5/8-406.1, of a Certificate of Public Convenience and Necessity (“CPCN”) for the Grand Prairie Gateway (“GPG”) Project (“Project”) as therein described, and an Order under Section 8-503 of the PUA, 220 ILCS 5/8-503, authorizing and directing ComEd to construct the Project. As and for its Amendment, ComEd states:

1. ComEd incorporates herein Paragraphs 1-24 and 26-36 of its Petition, Exhibits A through E thereto, and the prayer for relief requested therein. Additional detail is provided with respect to Paragraph 25 below. Also, in addition to the testimony identified in Paragraph 8 of the Petition, ComEd supports this request with all of the testimony and other evidence admitted into the record.

2. Pursuant to 83 Ill. Admin. Code § 200.150(h), a list containing the names and addresses of each record owner of privately owned tracts of land, upon or across which the

Primary Route will be constructed, as they appeared in the records of the tax collectors of the relevant counties as of November 12, 2013, a date not more than thirty (30) days prior to the December 2, 2013, filing of the Petition is attached to the Petition as Exhibit D and made a part thereof.

3. While not required by Section 200.150(h) of the Commission's rules, ComEd also included on Exhibit D to the Petition, the names and addresses of other owners of privately owned tracts of land upon or across which the Alternate Route segments could be constructed, and owners of privately owned tracks of land that lay adjacent to the parcels upon or across which the Primary Route and Alternate Route segments run.

4. ComEd alleges, on information and belief, that the Clerk provided notice to all parties identified on Exhibit D of the initial hearing in this proceeding, in the form required by Section 200.150 of the Commission's rules.

5. On April 20 and April 21, current owners of a parcel of property on the Primary Route on and across which ComEd proposes to construct the Project, contacted ComEd, requested additional information about the Project, and denied they had previously received individual written notice of the Proceeding from the Commission's Clerk. ComEd immediately investigated and determined that, although these landowners were not listed on Exhibit D, the relevant county assessors' office had not updated its records to show their ownership until November 13, 2013, well after the date 30 days prior to the filing of ComEd's Petition. However, ComEd also learned that that land ownership data for some parcels of property identified on Exhibit D were collected beginning 33 days before the filing of the Petition.

6. ComEd immediately appraised the Commission, the ALJs, and the parties of its discovery by submitting a Supplement to ComEd's Petition, a copy of which is attached hereto as Exhibit H to this Amendment and incorporated herein.

7. After ComEd filed the Supplement to its Petition, a dispute arose concerning the adequacy of notice provided in response to Exhibit D. ComEd contends that its original Exhibit D contained all of the names and addresses of those landowners legally entitled to notice of this proceeding. Moreover, the facts stated in the Supplement did not change the identity of a single party legally entitled to be listed on Exhibit D.

8. In the alternative, and without waiving any rights or conceding that Exhibit D was somehow incorrect or deficient, ComEd on May 23 and 24, 2014 voluntarily sent written notice via overnight delivery of the pendency of this Docket to persons who, as of May 23, 2014, appear in the relevant assessors' office's records as owners of land in three groups:

- a. Parcels on or adjacent to the Primary or Alternate Routes and who were not previously identified as owners of record on Exhibit D because the tax assessors' records changed after November 12, 2013 or, in the case of certain properties not on the Primary Route, where the taxpayer of record was listed on Exhibit D although a separate owner was identified.
- b. Parcels upon or across which an Intervenor in this Docket has proposed the Project should be constructed; and
- c. Parcels adjacent to alternative routes formally proposed by an Intervenor in this Docket, but upon or across which no construction is proposed.

The names and addresses of the persons in the first group are listed on Exhibit D-1 hereto; the names and addresses of the persons in the second group are listed on Exhibit D-2 hereto; and the names and addresses of the persons in the third group are listed on Exhibit D-3 hereto.

9. In accordance with 83 Ill. Admin. Code § 300.20, all landowners listed on Exhibit D, D-1, D-2, or D-3, should the Commission approve a route for the Project that requires an easement over their property, will be sent a notice letter and “Statement of Information from the Illinois Commerce Commission Concerning Acquisition of Rights of Way by Illinois Utilities” at least fourteen (14) days prior to any contact by ComEd representatives for the purposes of seeking an easement. The information contained in the letter and the Statement of Information will comply with the requirements of Part 300 of the Commission Rules.

10. ComEd submits this Amendment to place on record additional facts and information. ComEd does not by this Amendment modify its request to the Commission or otherwise seek to “restart” any time period provided by law relative to the requests made in ComEd’s Petition. To the extent any agreement or offer has been made by ComEd in regard to the timing of any Commission decision, that agreement or offer is unaffected by this Amendment.

WHEREFORE, ComEd respectfully requests that the Commission, (1) grant ComEd a CPCN for the GPG Project pursuant to Sections 8-406.1(i) and 8-503 of the PUA (220 ILCS 5/8-406.1(i); 220 ILCS 5/8-503); (2) authorize and direct ComEd, pursuant to Section 8-503 of the PUA, to construct the Project and place it into service; and (3) grant such other relief as the Commission deems just and necessary.





Donell Murphy, being first duly sworn on her oath, states:

1. My name is Donell Murphy. I am a Partner with Environmental Resources Management (ERM) located in Rolling Meadows, Illinois. I direct and supervise the work of ERM on behalf of Commonwealth Edison Company (“ComEd”) in connection with the Grand Prairie Gateway Project (Project).
2. On May 23, 2014, under my direction, ERM reviewed the records of the county tax assessors for each county in which ComEd or any intervenor in this proceeding has proposed the Project be constructed, and prepared Exhibits D-1, D-2, and D-3 of ComEd’s Verified Amendment to the Verified Petition based on the information available as of that date.
3. I have reviewed Exhibits D-1, D-2, and D-3 submitted with that Amendment. Exhibit D-1 is a list of owners of properties on or adjacent to the Primary or Alternate Routes and who were not previously identified as owners of record on Exhibit D because the tax assessors’ records changed after November 12, 2013 or, in the case of certain properties not on the Primary Route, where the taxpayer of record was listed on Exhibit D although a separate owner was identified. Exhibit D-2 is a list of owners of property upon or across which any intervenor has proposed that the Project be constructed. Exhibit D-3 provides a list of owners of properties adjacent to the properties whose owners are listed on Exhibit D-2. I am knowledgeable of the facts stated in the Amendment and attest that they are true and correct to the best of my information and belief.



SUPPLEMENT TO VERIFIED PETITION
OF COMMONWEALTH EDISON COMPANY

Commonwealth Edison Company (“ComEd”) submits this Supplement to its Verified Petition (“Petition”) seeking issuance, under Section 8-406.1 of the Public Utilities Act (“PUA”), 220 ILCS 5/8-406.1, of a Certificate of Public Convenience and Necessity (“CPCN”) for the Grand Prairie Gateway (“GPG”) Project (“Project”) as therein described, and an Order under Section 8-503 of the PUA, 220 ILCS 5/8-503, authorizing and directing ComEd to construct the Project. Supplementing its Petition, ComEd states:

1. ComEd filed its Petition with the Commission on December 2, 2013. The Commission’s Rules require that the applicant include with such a Petition “...a list containing the name and address of each owner of record of the land as disclosed by the records of the tax collector of the county in which the land is located, as of not more than thirty (30) days prior to the filing of this Petition.” 83 Ill. Admin. Code §200.150(h). That information allows the Commission to give notice to these parties of the “time and place scheduled for the initial hearing upon the application.” *Id.* As called for by that Rule, Exhibit D to the Petition identified the owners of record of parcels of land (other than ComEd controlled property) across which the Primary Route traversed. Petition, ¶ 25.

2. In addition, ComEd went well beyond that minimum requirement and also included names and addresses of the owners and/or taxpayers of record of approximately 1,550 additional parcels of property *adjacent to* its Primary Route and for parcels of property that were on or adjacent to the Alternate Route. This data was gathered from the same county assessors records or, where those records were incomplete, from responses to specific inquiries made to those offices.

3. After the end of the evidentiary hearings, ComEd learned of a controversy concerning a single parcel property in located in Kane County owned in part by Ms. Rachel Lange. A portion of that property is traversed by the Primary Route, but Ms. Lange was not identified on Exhibit D. ComEd has determined, however, that although her purchase of the property was recorded with the Recorder of Deeds on August 8, 2013, the Kane County Chief Assessor's office did not update the "records of the tax collector" to reflect her name and address until November 13, 2013, well after the date 30 days prior to the filing of the Petition. While ComEd has now updated its internal records to reflect Mr. Lange's ownership, she was not improperly omitted from Exhibit D.

4. During the course of investigating Ms. Lange's property, ComEd also learned that data was collected from the Kane County, DeKalb County, and Ogle County chief county assessors' offices as early as October 30, 2013, or 33 calendar days prior to the Petition's filing, apparently due to an error in accounting for weekend and holiday dates. ComEd and its contractor, ERM, revisited the county assessors' offices, collecting data as of April 24 for parcels on the Primary Route. Those records were then also individually compared with the records collected prior to the Petition on which Exhibit D was based, and ComEd and ERM have verified that this error in counting days did not result in the omission of any owner of record required to

be on Exhibit D, as submitted. Because Exhibit D to the Petition identifies all persons entitled to notice, no testimony or exhibit entered into evidence requires correction.

5. Further, on April 29 and 30, ComEd and ERM revisited the same county assessors' offices collecting updated data relating to parcels adjacent to the Primary Route and on and adjacent to the Alternate Route. Those records were also then compared with the analogous records collected prior to filing the Petition. Based on that review, ComEd also concluded that the additional names and addresses listed on Exhibit D relating to parcels not traversed by the Primary Route were not affected by any changes to those records that occurred between October 30 and November 4, 2013.

6. Facts relating to the collection of the landowner data are verified by the Affidavit of Ms. Donell Murphy, attached hereto as Exhibit A.

7. ComEd wishes to ensure that the Administrative Law Judges and parties are aware of the date on which this data was collected, but also that the record is full and accurate and that, to its knowledge, no party entitled to notice under the Commission's rules was omitted from Exhibit D. Accordingly, ComEd submits this Supplement to its Petition.





Donell Murphy, being first duly sworn on her oath, states:

1. My name is Donell Murphy. I am a Partner with Environmental Resources Management (ERM) located in Rolling Meadows, Illinois.
2. On October 30 and 31, 2013, the name and address of each owner of record of privately owned land as disclosed by the records of the tax collector, and upon or across which Commonwealth Edison Company ("ComEd") proposes to construct the Grand Prairie Gateway Project ("Project") in Ogle County, were obtained from the Ogle County Supervisor of Assessments Office.
3. On October 30, 2013, the name and address of each owner of record of privately owned land as disclosed by the records of the tax collector, and upon or across which ComEd proposes to construct the Project in DeKalb County, were obtained from the DeKalb County Chief County Assessment Office.
4. On October 30, November 1, November 2 and November 4, 2013, the name and address of each owner of record of privately owned land as disclosed by the records of the tax collector, and upon or across which ComEd proposes to construct the Project in Kane County, were obtained from the Kane County Assessment Office.
5. Under my direction and supervision, the name and address of each owner of record of privately owned land (not already owned or controlled by ComEd) as disclosed by the records of the tax collector, and upon or across which ComEd proposes to construct its Primary Route in Ogle, DeKalb, and Kane counties, were obtained from the three respective Assessment Offices on April 24, 2014. Based on review of the records

obtained on April 24, 2014 and comparing those to the records obtained in late October and early November of last year, it is my understanding that no changes were made to those records, or to the names and addresses they identify, by the Assessment Offices between October 30, 2013, and November 4, 2013, inclusive, that would have required notice to any additional persons not named on Exhibit D.

6. On April 29 and 30, 2014, also under my direction and supervision, ERM obtained from the three respective county tax assessors' offices data for privately owned land that is: (a) adjacent to (but not on) ComEd's Primary Route, or (b) on or adjacent to ComEd's Alternate Route (but not the Primary Route). Those records identified the owner of record and/or the taxpayer of record of these parcels. Based on my review of those records and comparing them to the records obtained in late October and early November of last year, it is my understanding that Exhibit D identified the owner and/or taxpayer of record of each such parcel as of November 4, 2013, and no changes were made to those records between October 30, 2013, and November 4, 2013, inclusive, that would change my conclusion.
7. Also under my direction and supervision, ERM investigated the status of Kane County Parcel 04-09-300-016. The owners of record of that property as currently disclosed in the records of the Kane County Assessment Office are Ms. Rachel Lange and Mr. Riley Skaggs at 12N032 Waughon Road, Hampshire, Illinois. They were not the owners of record disclosed in the records of the Kane County Assessment Office on October 30, 2013, the date on which ComEd first obtained its information for this specific parcel. I have also confirmed with the Kane County Assessment Office that records for this parcel were not updated to reflect Ms. Lange's and Mr. Skaggs' interests until November 13, 2013, so that a record search conducted on or before November 12, 2013, would not have disclosed Ms. Lange or Mr. Skaggs.
