WAIVER OF PROHIBITION OF EX PARTE COMMUNICATIONS

Now comes Intervenor CenterPoint Intermodal LLC, through its attorney, Michael J. Scotti, III, and pursuant to Section 200.710(a) of the Illinois Commerce Commission’s Rules of Practice, 83 Ill. Adm. Code 200.710(a), hereby waives the prohibition of Ex Parte Communications as follows: unilateral communications outside the presence of counsel to the respective parties to Docket T01-0064 will be permitted between the Illinois Commerce Commission railroad safety staff and the following:

- Engineering representatives, independent contractors, railroad police staff, operating department, and public affairs staff of the Union Pacific Railroad Company;
- Will County Sheriff’s Office
- Engineering representatives and independent contractors of the Illinois Department of Transportation
- Village of Elwood
- CenterPoint Intermodal, LLC
- BNSF Railway Company

Communication authorized under this waiver will be limited to the issue of discussing the potential stationing of police officers of the Will County Sheriff's Office, funding of police presence, and the safe implementation of police presence at crossing number 922 023D.

The Staff of the Illinois Commerce Commission shall memorialize all communications made or received subject to this waiver in writing and serve the memorializations upon all parties to T01-0064. The Staff of the Illinois Commerce Commission shall not be obligated to file notices of Ex Parte Communication in the public record of T01-0064 with respect to communication within the scope of this waiver.
