7. my public safety career with Union County 9-1-1 as the 9-1-1 Secretary/Assistant
8. Coordinator. In this position, I assisted in the development and implementation of
9. the enhanced 9-1-1 system which was approved by the Illinois Commerce
10. Commission on September 25, 1997 (ICC Docket 97-0380) In 2005, I was
11. promoted to Coordinator. I am responsible for all 9-1-1 operations and accountable
12. to the Union County Emergency Telephone System Board.
13. Q. What is the purpose of your testimony?
