**UNION PACIFIC RAILROAD COMPANY'S
PETITION FOR EXTENSION OF TIME**

NOW COMES UNION PACIFIC RAILROAD COMPANY (UP), and for its Petition for Extension of Time, respectfully states as follows:

1. On June 13, 2013, June 17, 2013, June 19, 2013, July 2, 2013 and August 1, 2013, the Staff of the Illinois Commerce Commission (Commission), Marion County Highway Department (County), the State of Illinois, Department of Transportation (Department or IDOT), Kinmundy Township Road District (Township), and Union Pacific Railroad Company (Company), respectively, executed Stipulated Agreement 1737 according to the provisions of Section 18c-7401 of the Illinois Commercial Transportation Law. The Stipulated Agreement, which is appended hereto, provides for safety improvements at the Shanghai Road highway-rail grade crossing of the Company's track near Kinmundy, Marion County, designated as crossing AAR/DOT #167 894D, railroad milepost 240.89-CC. Stipulated Agreement 1737 contains estimates of cost to accomplish the improvements and a division of cost among the parties.

2. UP hereby requests a 9 month extension for completion of the Project

because UP is waiting for the completion of the Marion County roadway improvements. The Marion County Engineer has indicated that the roadway improvements are still in the design / review process. The Marion County Engineer's office estimates that the project will not begin construction until October 2014. The project has a current Required Completion Date of September 18, 2014.

WHEREFORE, UP respectfully requests entry of an Order without hearing extending the current completion date for the Project from September 18, 2014 to June 18, 2015.
