**PLIURA INTERVERNORS  
RESPONSE TO ORDER CONCERNING CONTINUED HEARING DATE**

Pursuant to the September 16, 2014 ruling of the Hon. Administrative Law Judge, Pliura Intervenor, by and through their joint counsel, respectfully offer the following with respect to the proposed continued hearing dates:

September 19 at 10:00 A.M.: Staff has indicated its unavailability on this date. Counsel for Pliura Intervenor is presently scheduled to appear in the Circuit Court in Will County in an eminent domain proceeding filed by Enbridge in regards to its Line 78 project. Continuance of that proceeding would require the consent of Enbridge and the Court.

September 24 at 1:30 P.M.; Staff has indicated its unavailability on this date. Counsel for Pliura Intervenor is presently scheduled to appear in the Circuit Court in Kankakee County in an eminent domain proceeding filed by Enbridge in regards to its Line 78 project. Continuance of that proceeding would require the consent of Enbridge and the Court. Counsel for Pliura Intervenor is also presently scheduled to appear before a hearing officer for the Illinois Department of Public Health in an administrative hearing in the matter of *Illinois Health Facilities and Services Review Board v Advanced Ambulatory Surgical Center*. Docket No. 07-23, as day two of those proceedings.

October 1 at 10:00 A.M. or 1:30 P.M.; Counsel for McLean County has already indicated his unavailability for this date. Counsel for Pliura Intervenors is presently scheduled to conduct the deposition of a non-party witness in a pending civil case, *Porter v. Carle Clinic Association*, Vermilion County Case No. 10 L 22 as well as attending a hearing in another civil matter, *Bratberg et al v Atwater, et al*, McLean County Case No. 13 L 144.

October 2 at 10:00 A.M. or October 2 at 1:30 P.M.; Counsel for McLean County has already indicated his unavailability for this date. Counsel for Pliura Intervenors is presently scheduled to appear in the Circuit Court in Will County in a consolidated eminent domain proceeding filed by Enbridge in regards to its Line 78 project. Continuance of that proceeding would require the consent of Enbridge and the Court. Counsel inquired of Enbridge's counsel as to its willingness to continue that consolidated hearing but has received no response, as of the time of this filing. October 2 is doable subject to Enbridge's consent above.

October 8 at 10:00 AM or 1:30 P.M.; Counsel for Pliura Intervenors is scheduled to be in Will County Courthouse on behalf of landowner Bauer for a case management hearing. This is an eminent domain proceeding in Line 78. Continuance of that proceeding would require the consent of Enbridge and the Court.

October 9 at 10:00 A.M. or 1:30 P.M.; Counsel for Pliura Intervenors is available.
