NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING

Dear Sir/Madam:

Notice is hereby given that the Administrative Law Judge has completed a review of the application filed by Customer Acquisition Specialists of America, Inc. ("Applicant") on July 14, 2014 and hereby rules that the information described below shall be filed with the Chief Clerk of the Illinois Commerce Commission on or before August 27, 2014. The response to this ruling must include (1) the docket number, case caption, and an original signature, (2) a verification page, and (3) a certificate of service indicating that the response was served on all those on the service list. The response to this ruling must be actually received by the date indicated, regardless of whether the response is filed with the Chief Clerk electronically or as hardcopy. Applicant shall also electronically serve its response on the Administrative Law Judge (ekimbrel@icc.illinois.gov) by the date indicated.

1. Applicant is directed to respond to question number 7 in its application and disclose in what other jurisdictions the Applicant operates as an agent, broker, or consultant in a manner similar to that contemplated under Section 16-115C of the Illinois Public Utilities Act. Additionally, regardless of whether Applicant operates as an agent, broker, or consultant in Illinois or any other jurisdiction, the Applicant is directed to disclose whether it has had any complaints filed against it for its provision of any services in the electric or gas industry in this or any other jurisdiction. If any such complaints exist, the Applicant is directed to include in its response the nature of the complaint, the jurisdiction, and the ultimate resolution.


2. Illinois Administrative Code Section 454.40(c)(2) requires that an applicant for an ABC license submit certification that the applicant is licensed to do business in the State of Illinois. Applicant is directed to respond to question number 8(a) in its application and provide a Certificate of Good Standing from the Illinois Secretary of State evidencing that it is licensed to do business in the State of Illinois.
3. Illinois Administrative Code Section 454.80(a) requires that an applicant for an ABC license execute and maintain a license or permit bond issued by a qualifying surety or insurance company authorized to transact business in the State of Illinois. Applicant is directed to respond to question number 11 in its application and provide a license or permit bond using the sample ABC license or permit bond form found on the Commission's web site.
