MISSION:DATA, (www.missiondata.org) hereby petitions the Illinois Commerce Commission ("Commission"), pursuant to 83 Ill. Admin. Code Section 200.200, for permission to intervene in the above-captioned proceeding. In support of this Petition to Intervene, Mission:data states as follows:

1. Mission:data is a recently-established organization of companies that have developed software and technology tools that enable both commercial and residential consumers to gain information about their energy use and better manage that use to save energy and money. When authorized by customers (or utility partners, where utilities are the customer), our companies use customer energy data made available by advanced meters to deliver compelling energy management services and products to consumers.

2. Mission:data advocates across the country for open data access policies based on widely-adopted national standards and allow consumers to easily access and share their energy data with parties they have authorized to receive that data. Such rules are important to enabling the rapid scaling of energy management technologies and the timely realization of consumer energy saving benefits made possible by advanced metering.

3. Mission:data and its members have engaged in utility regulatory proceedings in a number of states on issues presented in the Open Data Access Framework .
4. Because this docket will establish the rules under which our member companies can access data on behalf of their customers, it will have a material effect on our companies and their customers.
