Dear Ms. Rolando:

On November 28, 2007, in Docket No. 07-0490, the Illinois Commerce Commission ("the Commission") granted EveryCall Communications, Inc. d/b/a All American Home Phone d/b/a Local USA ("EveryCall") a Certificate of Public Convenience and Necessity ("CCN") to provide non-facilities based local exchange and interexchange telecommunications services within the State of Illinois. At this time EveryCall would like to respectfully request that the Commission cancel its CCN and its tariffs.

EveryCall does not have any customers in Illinois and does not intend to provide telephone services in Illinois in the future. All annual reports have been filed and no fees are due from EveryCall. EveryCall respectfully requests that the Commission cancel its CCN and any tariffs previously submitted by EveryCall to the Commission. Accordingly, grant of EveryCall's request is in the public interest and no customers will be affected by cancellation of EveryCall's certificates and tariffs.


