Once an emergency unit is dispatched in response to a request through the system, such unit shall render its' service to the requesting party without regard to whether the unit is operating outside its' "normal jurisdictional boundaries.

The legislative intent is that 9-1-1 shall be used for emergency calls only. Therefore, all calls of an administrative or non-emergency nature shall be referred to your agency's published telephone number.

The PSAP agrees to keep all records, times and places of calls. All records will be available to participants of the 9-1-1 System.

CALL HANDLING AGREEMENT CONT.

It shall be the responsibility of the Pulaski/Alexander County 9-1-1 to maintain the report of calls and the disposition of each call received.

All agreements, management, records and service will be the responsibility of the advisory and policy board.

Any agreement or changes in agreement and operating policies must be approved by the advisory board.
