PETITION FOR REVIEW

The People of the State of Illinois (“the People”), pursuant to Illinois Supreme Court Rule 335 and Section 10-201 of the Public Utilities Act, 220 ILCS 5/10-201 (“the Act”), hereby petition this Court for review of the following orders of the Illinois Commerce Commission (“ICC” or “the Commission”) in ICC Docket Nos. 13-0501 and 13-0517, consolidated: November 26, 2013 (Interim Order); August 19, 2014 (Final Order); and September 30, 2014, served on October 1, 2014. (Notice of Commission Action denying the People’s Application for Rehearing.)

This Petition for Review seeks reversal of that portion of the Commission’s November 26, 2013 tariff and rate change order that rejected the recognition of accumulated deferred

income taxes in the calculation of interest on the reconciliation under- or over-recovery, and reversal of the Commission's September 30, 2014 Order denying the People's application for rehearing. The revisions authorized by the Commission's November 26, 2013 tariff and rate change Order took effect on January 1, 2014.

Attached hereto is a copy of the People's Notice of Appeal, filed with the Illinois Commerce Commission pursuant to Section 10-201(b) of the Public Utilities Act, 220 ILCS 5/10-201(b), together with proof of service of the Notice of Appeal.
