NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING
AND
NOTICE OF CONTINUANCE OF HEARING

TO ALL PARTIES OF INTEREST:

Notice is hereby given by the Administrative Law Judge that the Motion to Dismiss Verified Petition of the Citizens Utility Board and the Environmental Defense Fund ("Motion to Dismiss") filed by Ameren Illinois Company d/b/a Ameren Illinois (Ameren Illinois) ("Ameren") is denied. There is nothing in the statutory framework that precludes this proceeding. Indeed, the Petition seems to be a proactive approach to ensure that the Commission has adequate time to consider complex issues. For that reason, the Motion to Dismiss is denied.

However, the statutory framework is clear that ideas such as that proposed herein should be thoroughly vetted through the Smart Grid Advisory Council ("SGAC"). Commonwealth Edison Company ("ComEd") filed a Verified Motion to Stay the Proceeding ("Motion to Stay") requesting that this matter be stayed until April 1, 2015, at which time its Annual Report is due pursuant to Section 16-108.6(e). The Citizens Utility Board ("CUB") and Environmental Defense Fund ("EDF") indicate that they do not object to staying this proceeding.

Therefore the hearing in the above entitled matter scheduled for December 9, 2014, has been continued to April 1, 2015, at the offices of the Commission, Chicago, Illinois, Michael A. Bilandic Building, 160 North LaSalle, Suite C-800, at the hour of 10:00 A.M.

Notice is also given by the Administrative Law Judge that in order to ensure that adequate time is allowed for consideration of this issue, Petitioners should file a report on the status of discussions at SGAC regarding this issue by March 1, 2015.
