On November 3, 2014, we provided three copies of the prepared direct testimony and exhibits of Steven Lubertozi, Dimitry Neyzelman, Justin Kersey, Bruce Haas and John Guastella on behalf of Utility Services of Illinois, Inc. in support of the proposed tariffs. The testimony and exhibits were not affected by the inadvertent omission, and explain the nature, purpose and reason for the proposed sheets, and include the changes in rates as compared with the rates now in effect, the approximate number of customers affected, and the estimated increase in revenue resulting from the change in rates.
