

William Brudenell, President of Cost Advisor Inc, has been a licensed broker in the State of Illinois since 2011 while serving as the President of Commercial Energy Solutions, Inc (order #11-0408). In addition, Mr. Brudenell has an MBA from the University of Illinois in Champaign-Urbana.

In 1997, Mr. Brudenell started a company called Personnel Verification Technologies (PVT). The company grew rapidly and soon had six full time employees. Mr. Brudenell managed the entire staff from 1997 – 2004 when he sold the business.

Prior to 1997, Mr. Brudenell managed a staff of over 80 people at Bub's Pub and Pizza where he was the General Manager.

Subsequent to selling PVT, Mr. Brudenell managed subcontractors on jobs that ranged from \$150,000 - \$2,000,000. Often there would be up to 100 different workers on a project directed by Mr. Brudenell.

During this time, Mr. Brudenell either supervised and/or performed all electrical work done on residential and commercial custom builds and/or remodels.

In addition, Mr. Brudenell specialized in solar electric for homes and small commercial properties. He has personally installed 12 solar systems on roofs and ground mounts.


